

# 2nd Annual @PHLvisitorcenter Instagram Contest Independence Gift Shop Holiday Gift Grab

## **CONTEST RULES AND CONDITIONS:**

To provide a fair and equal chance of winning to all Independence Visitor Center Corporation guests, followers, and fans, the following are the official rules for the 2nd Annual Instagram Contest Independence Gift Shop Holiday Gift Grab.

No purchase necessary. Purchase will not improve chances of winning.

## **HOW TO ENTER:**

Contestants will enter the Sweepstakes by completing two tasks:

- (1) Follow @PHLVisitorCenter on Instagram AND
- (2) Leave a comment tagging two other Instagram users on any contest post shared by <a href="mailto:@PHLVisitorCenter">@PHLVisitorCenter</a> during the entry period.

Entries will be accepted for consideration during the Sweepstakes entry period, beginning December 2, 2019, at 8:30 a.m. EST, and ending December 13, 2019, at 11:59 p.m. EST.

## **ELIGIBILITY:**

Sweepstakes is open to any person 18 years of age or older who completes the entry tasks during the Sweepstakes entry period. Any entries submitted outside of the entry period will not be eligible for selection. To win, entrants must be available to participate in the winning Gift Grab event at Independence Gift Shop on December 20.

## **RANDOM DRAWING:**

One (1) potential Grand Prize winner will be selected in a random drawing held within one (1) day of sweepstakes ending date from among all eligible entries received and combined throughout the Sweepstakes Period. Odds of winning the Grand Prize depend on the number of eligible entries received throughout the Sweepstakes Period.



## **MERCHANDISE VARIETY:**

When participating in the IVCC Holiday Gift Grab, the sweepstakes winner may "grab" as many merchandise items as he/she can carry on his/her person and in one (1) designated basket provided by IVCC staff to the winner at the start of the Gift Grab event, during a period of **60** seconds.

The winner may not "sweep" the shelves or engage in any other behaviors that could result in unnecessary inventory damage. Sponsor reserves the right to clear the Gift Shop shelving of any merchandise that it sees fit prior to the winning event. The winner of the Sweepstakes will be contacted through messaging via Instagram on the account used to enter the contest, and the person receiving and replying to the winner announcement will be considered the winner unless: (1) they decline their selection, (2) they fail to respond to the Winner Notification within 24 hours, or (3) are unable to participate in the winning event on December 20.

Should any of these disqualifying circumstances occur, a new winner will be selected and notified, following the same confirmation steps. Independence Visitor Center Corporation is not required to award elsewhere any prizes forfeited by the chosen winner(s).

## **TERMS AND CONDITIONS:**

Sponsor reserves the right in its sole discretion to cancel, modify or suspend any portion of the Sweepstakes for any reason, including should any cause corrupt the administration, security or proper play of the Sweepstakes and, in the event of termination, to determine the potential winner in a random drawing from among all eligible non-suspect entries received and combined up to such time of impairment.

When participating in the IVCC Holiday Gift Grab, the Sweepstakes Winner will be liable for any physical damages to the event space and property that she/he commits through her/his participation. The Sponsor reserves the right to seek any and all remedies available for such damages to the fullest extent of the law.

# **DISPUTE RESOLUTION:**

Except where prohibited by law, as a condition of participating in this Sweepstakes, entrant agrees that (1) any and all disputes and causes of action arising out of or connected with this Sweepstakes, or prize awarded, shall be resolved individually, without resort to any form of class action, and exclusively by final and binding arbitration under the rules of the American Arbitration Association and held at the AAA regional office nearest the entrant; (2) the Federal Arbitration Act shall govern the interpretation, enforcement and all proceedings at such arbitration; and (3) judgment upon such arbitration award may be entered in any court having jurisdiction. Under no circumstances will entrant be permitted to obtain awards for, and entrant hereby waives all rights to claim, punitive, incidental or consequential damages, or any other damages, whether foreseeable or not and whether based on negligence or otherwise, including attorneys' fees, other than entrant's actual out-of-pocket expenses (i.e., costs associated with participating in this Sweepstakes), and entrant further waives all rights to have damages multiplied or increased.



# **CHOICE OF LAW:**
